#### **Matters Arising**

## **GOSHA** and Guernsey Awards for Achievement

Any organisation that strives for excellence in business must have a commitment to health and safety as an integral part of its culture. In addition good health & safety systems will have other benefits to an organisation.

Guernsey Occupational Safety & Health Association (GOSHA) wishes to sponsor a new award at Guernsey Awards for Achievement for Excellence in Health & Safety at Work.

Businesses would be invited to submit entries demonstrating excellence in health and safety at work. A panel of judges selected by GOSHA would select a winner by assessing entries against the following criteria:

- Evidence of management commitment to health & safety
- Evidence of occupational health & safety management systems
- A culture that encourages good health & safety practice throughout the workforce
- Evidence that the organisation promotes the development of Managers and staff through relevant health and safety training
- Evidence of a rigorous approach to occupational health among its workforce
- Evidence of good compliance with safety systems
- A low accident/incident rate
- Good relationship with the HSE

AM thanked SR and MM for there input into this matter. The consensus of the committee was that this specification could only be met by a small number of larger companies on the Island. JC suggested the award should be aimed at a Business that has made the most improvement. MM stated that businesses applying for this award want to gain as much publicity as possible. AM advised that the award will be deferred to 2009 because the deadline for 2008 was too close and a specification has not been agreed yet. AM asked for someone on the committee to take this forward.
