The Guernsey Health and Safety Executive Team have recently forwarded details of accidents, injuries and illnesses reported to them during 2006.

The incidents which must be reported to the Health and Safety Executive team are detailed in the Health and Safety Ordinance and are explained in the booklet Reporting an Injury, Disease or Dangerous Occurrence available free of charge from the Guernsey HSE (see also www.hse.guernsey.gg/reportingaccident.html).

Reportable incidents are serious in nature and the consequences can be significant both in terms of interruption to a business and damage to its reputation. They can also have significant personal consequences for the individual involved and their family, work colleagues and friends.

Whilst it is pleasing to note that the total number of reported incidents fell in 2006, the total number still exceeds 400 and more than half arose from poor manual handling, a topic covered in one of our 2006 talks.

Life is full of risk, much of which cannot be removed, but many accidents and other incidents could easily be avoided. There is plenty of guidance information available from GOSHA, the Health and Safety Executive team in Guernsey, various Guernsey based consultants and the UK Health and Safety Executive to assist in reducing the total number of incidents. Have a look at our website for links and let's all play our part to keep the number of incidents right down in 2007.

The figures given remain provisional pending further advice from the Guernsey HSE Team.
