**Fireworks** – there are tight controls on the commercial storage, distribution and sale of fireworks in Guernsey and for good reason. As 5<sup>th</sup> November approaches, those organising displays for groups of employees, club members and so on should remember that professionally organised displays are the safest way to enjoy a fireworks event.

**Dial before you dig (**<u>www.electricity.gg/onlineservices/db4udig/onlinerequestform.asp</u>**)** – if you are planning to carry out groundworks, please contact Guernsey Electricity before you dig to check that you will not inadvertently damage underground cables – if you prefer, you can do this through the website link.

**Food Hygiene** – a reminder - any staff member involved in preparing or handling unwrapped foods should receive training to at least the Level 2 Award in Food Safety in Catering (or equivalent) within three months of commencing employment. Other staff involved in a restaurant, catering or related business (e.g. waiting staff, delivery drivers, pot wash staff etc) should be trained in hygiene issues relevant to their duties. When commencing employment, staff should receive supervision to ensure that they are carrying out their duties in a suitable and hygienic manner.

Training courses are run by the Guernsey Environmental Health Department and other training providers in Guernsey (see <a href="https://www.gosha.org.uk">www.gosha.org.uk</a> for examples).

**Gas Safety – Landlords –** The Health and Safety (Gas) (Guernsey) Ordinance, 2006 specifically deals with the installation, maintenance and use of gas appliances, fittings and flues in domestic and certain commercial premises. With winter approaching, please ensure you know your duties and make sure that all required inspections, maintenance and other work is carried out by a CORGI registered installer. - AGM 22.11.07 at La Trelade Hotel (18:00 start) if you are not already a committee member and would like to stand for election to the GOSHA committee, please let Jon Coyde, our Secretary, know by 23.10.07. Our talk on that evening will be given by Alan Chubb of Guernsey Electricity, beginning at 18.30.
- Open meeting 20 September 2007 Rob Shaw from the Health & Safety Laboratory in Buxton gave an excellent presentation to around 40 members on the subject of slips, trips and falls. Lots of thought-provoking comment and information including the very serious consequences of slips on level ground (as opposed to those involving a fall from height) and resulting in an average of 9 amputations in the UK each year and 36% of all major injuries. We heard how simple risk assessments and management action can reduce or eliminate these incidents (such as the better placement of handrails, the use of appropriate footwear and floor coverings and the effective and timely cleaning of surfaces which become hazardous).
