Disabled people and businesses in Guernsey – you may like to be aware that the Guernsey Disability Alliance has recently been formed to represent the interests of all disabled people in Guernsey. Nearly 11,000 islanders have a long-standing condition that restricts daily activities and there are more than 1,000 wheelchair users. If businesses do not provide for the needs of disabled people, they miss out on valuable trade and some very good employees. Asbestos – the hidden killer – focus on tradespeople – during October and November 2008, the HSE is running a special campaign to target tradespeople such as plumbers, electricians and joiners who are at risk from exposure to asbestos in buildings and other areas in which they work. The primary aim is to raise awareness and to highlight that many people are more at risk than they think from asbestos. CHIP regulations – new UK law to be aware of - The Chemicals (Hazard Information and Packaging for Supply) (Amendment) Regulations 2008 enter into force on 1 October 2008. The changes do not affect the main legal duties but do adjust:

- the rules and procedures for classifying and labelling a chemical preparation containing carcinogens, mutagens and substances toxic for reproduction;
- the generic concentration limits to be used for the evaluation of the hazards for the aquatic environment;
- the classification and labelling requirements for preparations containing ozone depleting substances;
- the specified warning phrases on labels for certain preparations to make them clearer and more consistent.

There have been many reports of HSE, and health and safety law, being responsible for banning all sorts of things. For example, flip flops at work, knitting in hospitals, school sports days, a charity Christmas swim and even cuddly toys on dustbin lorries. In reality, the HSE has banned very little outright, apart from a very few high-risk exceptions. The HSE believes that health and safety should be about taking practical steps to manage real risks, not bureaucracy leading to the banning of everyday activities.
